## ATTENTION EXHIBITORS

Eukanuba Hall is open for set-up on Thursday, October 15, 2015. Please check schedule to see the exact time on Thursday morning. Dogs must be removed from Eukanuba Hall with an hour of the end of the activities each day.

Exhibitor crating in designated areas only.

The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. Dogs need not arrive until scheduled time of judging and will be excused after they are judged, if not required for further judging.

**This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.**

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). An AKC Recording Fee of \$3.50 1st Entry & \$3.00 additional entry of same dog will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 3) These Fees are paid to the American Kennel Club.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

There will be no refund for duplicate entries.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Class Judging.

Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

The Club reserves the right to substitute a prize of equal or greater value.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Secretary.

The show giving Club, the Show Secretary, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.



## GROUNDS RULES

Dogs will not be permitted in any of the hotel recreation areas, including the swimming pools, and any other areas to be stipulated as "non-dog" locations.

Dogs will not be permitted in food and beverage outlets, with the exception of those assisting the disabled.

There will be a sufficient number of dog walking/exercising areas and a site map will be provided with the designated areas clearly marked. These areas will also be staked and marked with colored tape so it is evident where they are located.

There will be trash receptacles in the designated exercised areas for deposit of waste.

The HPCA will provide plastic bags and appropriate scoops, etc. for the collection of waste.

**Pick up and removal of waste will be the responsibility of each dog owner/handler.**

The HPCA Grounds Committee will continuously monitor all exercise areas to assure that members comply with the rules.

Those using soft-sided crates in Eukanuba Hall do so at their own risk should the dog get out of the crate.

Convention Center doors must be closed during event hours for safety of the dogs.

No dogs can be left in Eukanuba Hall after all activities are finished.

## ROOM RESPONSIBILITY

Any individual attending an HPCA Sanctioned Event and staying in a hotel, motel, inn or campsite/fairground has the responsibility of leaving that room or campsite exactly as found. This includes picking up after dogs on the grounds. Anyone who damages a room or campsite/fairgrounds and does not report the damage to the hotel/campsite/fairground management and make immediate restitution or arrangements to do so within a period of time agreed upon by the management, will be subject disciplinary action by the HPCA Board of Directors.

The HPCA will provide sheets of plastic to place under the crates. Up to four dogs will be permitted per room.

The hotel will provide sheets to place over the beds in guestrooms with dogs.

All dogs left unattended in hotel guest rooms must be crated, no soft-sided crates.

Housekeepers will not have to service rooms in which dogs are loose and unattended. Moreover, they will be required to report this rule violation to hotel management. A pet deposit of \$35 will be charged for each room in which a dog is housed per stay. Individual room occupants will be assessed for any damage or destruction to their room.

All dogs must be crated and quiet when left alone in a room. Noisy dogs shall be quieted upon request, even if this means the owner/handler must stay in the room with the dog.

Dogs are to be allowed on furniture ONLY if the furniture is covered with protective covering provided by the owner/handler.

Dogs will be bathed in designated areas for dog washing. There will be no grooming of dogs in hotel rooms and no hotel towels will be used for this purpose.

All owner/handlers will take preventative measures to assure that their dogs are free of fleas, mites, intestinal parasites and other communicable diseases prior to arriving at the hotel/campsite.

Individuals will be expected to immediately report any damage by dogs or themselves to the hotel/campsite/fairground management and to assume complete financial responsibility for those damages.

The HPCA will have a liaison to meet daily with the Head of Housekeeping and hotel management to assure that all of its members are complying with hotel rules. Any offenders will be asked to leave hotel immediately.

Damages shall be defined as flea infestation, urine, defecation and/or any damage to hotel/campsite/fairground property (walls, bedspreads, carpets, drapes, etc.).

BY SIGNING ANY HPCA ENTRY FORM, COMPLIANCE WITH THIS POLICY SHALL BE INSURED. ALL INDIVIDUALS ARE REQUIRED TO COMPLY.

## Congratulations Pumik Qualifying for a CHIC Number

The Hungarian Pumi Club of America is proud of their members' dogs who have completed all their recommended health tests for their Pumi and agreed to have the results released to the public domain. The dog must also have a permanent identification, such as a tattoo or microchip. When all the tests are completed, the dog receives a CHIC (Canine Health Information Center) number. The required tests are for Hip Dysplasia (x-ray), Patellar Luxation (exam), Primary Lens Luxation (DNA), and Degenerative Myelopathy (DNA). The CHIC number does not imply normal test results, only that all tests were performed and made public. You can see a current list at [www.offa.org](http://www.offa.org).
