CONDITIONS OF ENTRY

Dogs must have an AKC registration number and be at least one year of age on the day of the trial. Dogs may run once per test. All mailed entries must be accompanied with a check to be valid. Incomplete entries or forms without signatures will not be accepted. Online entries are recorded immediately.

FAST CAT events are open to all dogs, at least 12 months of age that are individually registered with AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration or dogs enrolled in the AKC Canine Partners program.

Dogs with breed disqualifications and monorchid/cryptorchid are eligible to participate.

Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion.

The inspection committee has the authority to disallow a dog's entry into a test and, in such instances; applicable entry fees will be refunded. At roll call, all dogs will be measured by a wicket to verify handicaps. Bitches in- season, lame or unfit dogs will be excused with entry refunded.

WHAT IS A FAST CAT?

FAST CAT events are open to all dogs at least 12 months of age that are registered with the AKC, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration and dogs enrolled in the AKC Canine Partners program on the day of the trial. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate.

If your mix breed dog needs an AKC Canine Partner application, a link is below. You can pay by credit card. You can also apply the day of the trial, see the Trial Secretary.

Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The inspection committee has the authority to disallow a dog's entry into a test and, in such instances; applicable entry fees will be refunded. At roll call, all dogs will be measured by a wicket to verify handicaps. Bitches in season, lame and unfit dogs will be excused with entry refunded.

Please do not bring bitches in season to the trial.

FAST CAT is a timed straight 100 yard dash for dogs. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into the catch pen. The course is completely fenced and dogs run individually. Dogs are timed when they complete the 100 yard dash. The time is converted to Miles Per Hour (MPH)

Formula: $204.545/\text{run time} = \text{MPH}$

$\text{MPH} \times \text{HANDICAP} = \text{POINTS}$ (ROUNDED TO THE NEAREST 0.01)

Based on the dog's size at the withers, a handicap is applied and points are earned.

- 18" or greater = Handicap is 1.0
- 12" up to 18" = Handicap is 1.5
- Below 12" = Handicap is 2.0

MPH X HANDICAP = POINTS

Titles are earned at specific point levels and the highest suffix may appear after the dog's name:

BCAT = 150 POINTS

DCAT = 500 POINTS

FCAT = 1,000 POINTS

FCAT# - EACH ADDITIONAL 500 POINTS

According to AKC Rules: Handlers are NOT ALLOWED to run with a dog during an official run but must remain either at the start or finish area of the course. Handlers are NOT TO ALLOW dogs to enticed through the course with anything other than the lure during its official run. NO Mechanical devices including whistles, horns, bull horns or toys including waving of objects to lure the dog to the finish line. You MAY CHEER and use the dog's name ONLY.

TOP 20 BY BREED BY YEAR

The AKC FAST CAT website will feature the TOP 20 Fastest Dogs by Breed by Year National Standings. The standings will be updated as event results are processed at <http://www.apps.skc.org/apps/fastcat.ranking>

TRIAL HOURS

Grounds will be available one hour prior to trial hours. Trial will promptly at 9am with worker dogs and until all runs are completed at 3PM. It is the responsibility of each entrant to be ready with catcher and releaser when their dog is called to the line. Concurrent trials will be in effect. Once your two runs are completed, you must leave the grounds.

TRIAL TIMES

Concurrent trial starts at 9:00AM each day and until 3:00PM
HPCA, Inc. and HCTC will do its best to accommodate exhibitors with
conflicts in other venues, BUT CANNOT GUARANTEE. However,
exhibitors must notify the Trial Secretary of Conflicts and work their dog
into the running order during the schedule.

Dogs will run in one hour scheduled blocks.

Check in for inspection FROM 8AM & 9AM on Saturday and Sunday
prior to the beginning of the trial.

You MUST check in again for your second run. Each dog MUST pass
through inspection before each run. Dogs who miss roll call will be
skipped. If you do not check in within one hour prior to the end of the
trial closing, we will assume you are absent. It is the responsibility of each
entrant to be ready with catcher at the catch pen and releaser when their dog is
called to the line.

TRIAL INFORMATION

- Please pick up your dog so we can continue to use this wonderful site. Any exhibitor caught not cleaning up after their dog or any loose unentered dog will be asked to leave the trial grounds. NO REFUND will be given if this occurs.
- A fine will be assessed for any loose dog on the field not competing.
- Dogs should be warmed up before and cooled down after running.
- **ALL DOGS RUN AT THE OWNER'S SOLE RISK.**
- All entries must be 12 months of age or older on the day of the test.
- All AKC rules regarding sportsmanship and conduct apply.
- This is a rain or shine outdoor event. Plan accordingly. Please bring your own shade, chairs, HAND SANITIZER and water.
- An electronic timing system will be used. An electric continuous loop, plastic strip lure machine will be used.
 - The show grounds are NOT completely fenced, the FAST CAT course will be fenced.
- Porta John will be available on site.
- Dogs must be on leash or crated unless running.
- You are responsible for controlling your dog and children. Only one handler may be in the catch pen at a time.
 - Each dog requires an individual entry. You may use one form to enter one dog for some or all events. Use the checkbox and indicate each event you wish to enter, \$30.00 per entry.
 - The HUNTMASTER is responsible for field safety and therefore he/she is in complete charge of ALL DOGS and HANDLERS on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Persons exhibiting conduct detrimental to the Sport of Pure-Bred Dogs, AKC, HPCA, inc., HCTC or any dog(s) or other person(s), will be asked to leave the trial site by the Field Committee, may face discipline by the Bench Committee and AKC. **Entry fees will not be refunded.**
- **NO ENTRY FEES WILL BE REFUNDED** if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, strikes or any other cause beyond the control of the clubs or the event-hosting club.
- HPCA, HCTC, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after these events.
- Club members **WILL NOT BE AVAILABLE TO RELEASE DOGS, PLEASE PLAN AHEAD.**
- Collar Rules: Dogs may run without a collar or wear any type of collar except choker collars, electronic collars or head collar (Gentle Leader). Collars should be snug. Hanging tags pose a safety concern and it is suggested that tags be secured to the collar with tape. Dogs may run muzzled if desired. Clips and rubber bands may be used to keep long hair from falling in the dog's field of vision.
 - It is suggested that exhibitors wear close toed shoes for their own safety!
 - Some motels charge a pet fee or have limits on size. All exhibitors be aware that the entire motel, RV and trial site are considered within the trial grounds. Any abuse of the grounds will be brought to the attention of the trial event committee & is supported by the AKC.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
